## INFORMATION FOR ASBMR 2011 ANNUAL MEETING CONCURRENT ORAL PRESENTATIONS

Your work has been highly valued by a stringent peer review system and is expected to receive a lot of attention at the scientific meeting. The ASBMR Program Committee asks that you take considerable care with its presentation. Please rehearse your talk with your colleagues so that you are confident your presentation is clear, the slides are easy to read and understandable, and you do not run over the time allotted. Be prepared to answer questions on your work. If you feel you are unable to give a clear presentation and/or to fully understand and answer questions, the talk should be given by a colleague who can. If this is the case and another colleague will make the presentation on your behalf, the colleague should make sure to notify the moderators of this change prior to the start of the session. If you have received NIH or other funding for the work presented in your presentation and/or have any Conflict of Interest information, please make sure to include acknowledgment of this support or disclosure information on the second slide of your presentation. It is not necessary to acknowledge every co-author verbally; this acknowledgement should be made on a slide included in your presentation.

Also, ASBMR must be informed immediately if a paper is to be or has been published in print before the meeting.

If your presentation is treatment-related, you must give a balanced view of therapeutic options by providing several treatment options, whenever possible, and by always citing the best available evidence.

## SLIDE PRESENTATION INSTRUCTIONS

## **Slide Type:**

Data projectors for Microsoft PowerPoint (ONLY) will be provided in all session rooms at the ASBMR Annual Meeting. You will need to prepare your slides using PowerPoint. You may use an IBM-compatible or Macintosh version of PowerPoint.

<u>File Name</u>: PowerPoint files should be saved in the following way (separated by underscores): "Date\_Room\_ StartTime\_LastName\_FirstName\_program number.ppt" (if applicable) (e.g., 091711\_103A\_1200\_Smith\_Scott\_WG1556.ppt)

(Do NOT use the abstract control number.)

(Please note: ONLY abstract-based presentations will have a program number.)

<u>Slide Submission</u> (REQUIRED): All presenters MUST submit their slides by one of the following options: e-mail, on-line upload or mail to AVMG (ASBMR's vendor for audiovisual services and equipment) BY Friday, September 9:
